Why crime victim service providers oppose “Marsy’s Law”

As the state of Iowa’s network of victim service providers who are members of the Iowa Coalition Against Sexual Assault and the Iowa Coalition Against Domestic Violence, we unconditionally support victims and survivors of violent crimes. However, we believe establishing constitutional rights for victims is the wrong mechanism for advancing victims’ rights and effectively meeting the diverse needs of survivors.

Our agencies provide survivors, families, and communities who have been impacted by a violent crime in all 99 counties with 24/7 free and confidential support and services. In addition to providing crisis response, we assist law enforcement at crime scenes and support sexual assault victims at medical facilities. Lawyers and judges rely on us to accompany, guide, and support survivors in court and legal proceedings. We help survivors obtain housing, public services, jobs, and access to safety and services that help them rebuild their lives. Last year, our agencies served 57,801 victims of violent crimeⁱ.

Opposing a constitutional amendment does not mean we oppose victims’ rights. We simply believe a constitutional amendment will not improve access to rights, services, and the ability to find justice and healing. Establishing constitutional rights without meaningful remedy or resources to ensure victims can access these rights is an empty promise. Having a constitutional right to be notified does not mean the state will invest the resources it needs to improve victim notification. A victim cannot exercise their right to be heard in court if they cannot afford a lawyer or a job that allows them time off or if they have no transportation to the courthouse.

Importantly, these proposals *only* elevate the rights of the small number of survivors who pursue remedies in criminal court. What about the vast majority of crime victims who do not or cannot seek remedies in our criminal legal system? Many domestic abuse victims never call the police because the risk of retaliation from the person who harmed them is not worth compromising their individual and family safety. Many sexual assault victims never get their day in court. Out of every 1,000 rapes that occur, only nine will ever get referred to prosecutors in the first placeⁱⁱ. That’s less than 1 percent. Having constitutional rights does nothing to address the needs of the overwhelming majority of crime victims in our state.

Iowa law already includes comprehensive victim rights and protections that aim to meet the needs of all victims. Additionally, our state has a good sense of needs and gaps in services. Victim needs identified in the 2016 Crime Victim Assistance Division’s (CVAD) statewide survey include housing, transportation, employment, health care, childcare, counseling, lack of access to legal services, and lack of awareness of rights and servicesⁱⁱⁱ. Of course, we can do better. But before amending the constitution, we should ensure that victims are aware of their rights, and that the systems and services needed to access and benefit from them are adequately supported.
