She went on to George Mason University School of Law (GMUSL) in Arlington, Virginia, where she was published in, and served as Articles Editor of, the GMUSL Civil Rights Law Journal. Vanderhorst was also the third-seated graduate of the Class of 2002 at the Howard University School of Divinity in Washington, DC, and received the school's Dean's Award and Durley Award as was published in her capacity as a Faith Leaders Initiative Fellow.
